#### **OTHER ITEMS:**

1. Central Oregon Dressage Classic Sponsorship

Abbie Block, owner of Absolute Horse, provided information about her costs associated with sponsoring the Central Oregon Dressage Classic. In return for advertising, vendor space, and other benefits, Absolute Horse provides shirts for volunteers at a retail value of approximately \$3,500. She expressed concerns the level of support other vendors contribute to the show and the equity of vendor fees. The Board discussed options for helping to offset the expense to Abbie, including finding additional sponsors and/or reimbursing her for a portion of the cost of the donated shirts. A decision will be made at a future unspecified ad hoc meeting date. The Board also discussed ways to mitigate this issue at the next show, including accepting cash-only sponsorships and not accepting in-kind donations. These alternatives will be revisited at a later date.
